**FCSB – ABERDEEN FC**

*- Public order and safety measures –*

**Thursday, 28th of August 2025, starting at 21:30 hrs., UEFA Europa League football match between FC FCSB and Aberdeen FC will take place on the National Arena Stadium in Bucharest.**

In order to have a safe, secure and welcoming event, Bucharest Gendarmerie, along with the other relevant authorities, will adopt the necessary measures in order to insure the safe movement of fans to and from the stadium as well as to maintain a climate of security through the entire city of Bucharest.

In the Old City Center, the gendarmerie and police forces will work together in an integrated system, to ensure public order and safety.

On this occasion, **Bucharest Gendarmerie will deploy dialogue teams composed of english speakers**, in order to facilitate communication with the guest fans.

**Fans access** to the stadium will be allowed starting with **19:30 hrs.**, based on the tickets provided by the organizer.

**Away supporters traveling to the stadium from the Historic Center of the Capital and back will have access to bus line 600, specifically designated for them. Each person will need to pay the travel fare upon boarding (card payments are also accepted).**

**For their safety and that of other citizens, we recommend that visiting supporters avoid traveling on the routes used by the FCSB team's supporters. Therefore, we mention the following routes to avoid: Piața Unirii, Unirii Boulevard, Piața Alba Iulia, Decebal Boulevard, Piața Muncii, and Basarabia Boulevard.**

Access for visiting supporters will be strictly controlled under the guidance of law enforcement, through a specially designated entrance from Pierre de Coubertin Boulevard, and they will be escorted to the specially designated area at the North Stand, after a rigorous control carried out by the Gendarmerie and the specialized protection and security company.

For safety and security reasons, **Bucharest Gendarmerie recommends the following:**

- *we advise supporters **not to get involved in incidents** that could lead to disturbance of public order and peace, that can result in any form of verbal or physical violence;*
- *spectators **are not allowed** to bring to stadium the following: **alcoholic beverages, pyrotechnic materials** prohibited by law **or other objects that may endanger** the safety of participants in this sport event. It is forbidden to display banners that promote national, racial, class or religious hatred, discrimination of any kind and violence;*
- *in order to prevent incidents, we recommend to avoid traveling in large groups to or from the sports arena;*
- *please report any problems you encounter to the authorities.*

In accordance with the provisions of the local **Law no. 4 of 2008 on preventing and combating violence during competitions and sports games**, with subsequent amendments, entrance to the stadium, public access by turnstiles, guarding of locker rooms and protection of referees, guidance and supervision of the public in the stadium is performed by a stewarding company, contracted by the organizer.

**According to art. 14 of the aforementioned law, prior to allowing access to the National Arena Stadium, participants in this event will be subject to a preventive body search, performed by the stewarding company contracted by the organizer, in order to prevent entering the stadium with dangerous materials or objects for the spectators safety.**

**In the same context, the spectator who commits, before entering the sports arena or at the moment of entry, acts of a criminal or contravention nature related to the respective competition or game, will not be allowed access to the sports arena.**

Law enforcement agencies have the authority to take photo and video footage for the entire sport event and in public places. These can be later used as pieces of evidence for any criminal abuse or public offences.
